Stage 1

Stage 2

An individual, family member or carer raises concerns about a person's sight,

Optometrist (optician) notes abnormality during regular eye test, OR

GP suspects loss of vision.

Stage 3

Wherever possible the optician treats and/or monitors the eye condition, or a professional refers the person to an Ophthalmologist who diagnoses the eye condition or community low vision clinic for advice on low vision aids.

Stage 4

Treatment is administered if appropriate. Most sight loss is treatable and preventable. Early treatment can make the difference.

If significant sight loss is permanent the Consultant Ophthalmologist should offer to issue a Certificate of Vision Impairment (CVI) appropriate to the level of vision. This will indicate whether the person can be registered as Sight Impaired or Severely Sight Impaired with the Local Authority.

Stage 5

A member of the Eye Clinic staff refers the person to meet the Eye Clinic Liaison Officer (ECLO) who guides them through the process of certification.

The ECLO advises the person, the carer, or advocate on support available outside the Hospital and how to access it.

Stage 6

The CVI is sent by the Hospital to the Local Authority.

The Local Authority contacts the person to confirm that they want to be included on their register and offer a sensory assessment of need.
