Dear Doctor,

The Senior Coroner is writing to all the General Practitioners in Barnet, Brent, Enfield, Haringey and Harrow to provide an update to the Coroner's Service in this area.

The Coroner's Service has successfully introduced a form that hospital doctors complete when referring a death to the coroner. Following requests from a number of doctors in the community that they use this form for reporting deaths to the Coroners Service it was decided to pilot a form for GP's to report a death to the Coroners Service.

The advice given to the staff at the Coroner's Service is set out below and has been included for your information.

**The Senior Coroner proposes the following guidance:-**

That the Coroner's Service is not able to give advice on the medical cause of death the Doctor wishes to write on a Medical Certificate of the Cause of Death.

The Coroner's Service will provide advice about whether a death needs to be reported to the Coroner's Service having regard to the medical cause of death and the circumstances in which the death occurred.

Whether requesting advice from the Coroner's Service about a death or reporting a death to the Coroner's Service the Doctor will be required to complete a GP Written Referral Form following the commencement date for each GP area.

The Coroner's Service will refer the Doctor to the relevant Registrar's office if the Doctor seeks advice about whether a particular cause of death would be acceptable to the Registrar.
